

Significant CCWIPP changes announced

A message from UFCW Local 175 President Haggerty

Changes to the Canadian Commercial Workers Industry Pension Plan (CCWIPP) have now been announced by the Board of Trustees. The changes will take effect July 1, 2015. These changes are significant and will affect all CCWIPP members (active, inactive, and retired).

The concerns listed in the 'Your Pension' newsletter in April – to deal with the plan's current funding shortfall and to improve its financial position over the long term – have been addressed by the CCWIPP Board of Trustees. These changes have been approved by the Financial Services Commission of Ontario (FSCO).

I know that these changes will be difficult. I am committed to supporting you through the challenges that lay ahead in the following ways:

- Union Reps will reach out to the members at each bargaining unit to talk about the changes and schedule meetings by workplace.
- Extra people will be brought on staff and a CCWIPP Info Line has been set up to answer your questions.

- Local 175 Executive Board Vice-President and CCWIPP member Jim Montgomery will be available full-time to answer RETIREE questions exclusively. Retirees should call the CCWIPP Info Line number to be put in touch with Jim.
- I have hired an independent actuary (pension expert) to evaluate the plan's future benefit structure.
- Local 175 will maintain a special pension web page (ufcw175.com/yourpension) which will contain copies of each Your Pension newsletter and any additional information and resources as they become available.

The changes announced by CCWIPP are very complex and there are distinct variations between bargaining units. I urge you to attend the meeting that will be scheduled for your area shortly, to get more details on how the changes will apply to your workplace.

Please stay informed and make sure to check your Union bulletin board at work for meeting dates and locations.
